

APPLICATION FOR RETIRED CITIZEN CLASSIFICATION-RATE CHARGE

WOOD VILLAGE ORDINANCE 4-2005 AMENDING ORDINANCE 3-1973 PROVIDES THAT A RESIDENT OF THE CITY OF WOOD VILLAGE FOR A PERIOD OF AT LEAST SIX MONTHS WHO IS COLLECTING RETIREMENT INCOME DUE TO AGE OR DISABILITY AND WHO MAINTAINS FOR THEIR PERSONAL USE A SEPARATE LIVING UNIT IN WHICH ALL ADULT PERSONS RESIDING ARE RETIRED AND MAKES DIRECT PAYMENT TO THE CITY OF WOOD VILLAGE, IS ENTITLED TO MAKE APPLICATION TO THE CITY RECORDER FOR "RETIRED CITIZEN CLASSIFICATION" AND UPON SUCH QUALIFICATION, RECEIVE FROM THE CITY A FORGIVENESS OF 25% OF THE MONTHLY MINIMUM CHARGE (BASE FEE) FOR, WATER AND SEWER USAGE SO LONG AS THE APPLICANT REMAINS QUALIFIED.
